Method of Manufacture

Into the main vessel add:

Aqua	Start the mixer on a fast speed
Disodium EDTA	Mix until dissolved
Cetpro Thix Carbomer	Mix until dissolved and no lumps remain
SunSHINE® Crystal Golden	Mix until uniformly distributed and no lump of powder remain

Reduce the mixer speed to slow and add the following into the main vessel:

Triethanolamine	Mix until homogenous. The product will thicken up during this stage.

Into the main vessel add:

Resplanta Olea	Mix until homogenous
Euxyl PE9010	Mix until homogenous

Mix for a further 30 minutes to ensure the bulk is completely mixed and homogenous.
